SCOPE AND CONTENT NOTE

In July 1956, Phillip E. Areeda was appointed Special Assistant in the White House. On November 13, 1958, he was appointed Assistant Special Counsel to the President. As Assistant Special Counsel, Areeda helped draft and research White House staff studies dealing with economic and legal matters. He was under the direction of David W. Kendall, Special Counsel, and Henry R. McPhee, Associate Special Counsel. In addition, part of his duties were under the direction of Don R. Paarlberg, Special Assistant to the President for Economic Affairs. Areeda continued in his duties until the end of the Eisenhower Administration.

The file consists of printed House Documents and Reports, memoranda, press releases, a few drafts of speeches wit editing notes, printed materials, statistical material, correspondence, and other materials of an economic and legal nature. The Principal subjects covered are agriculture, consumer installment credit, trade, the National Cultural Center, unemployment compensation, and the Washington Conference for the Advertising Council. No original over-all arrangement was apparent. The folders have been arranged alphabetically in three different sections.
