SERIES DESCRIPTION

This series consists of the talks and papers written or presented by Richard M. Bissell over the course of his life beginning with his early school days and continuing to well beyond his retirement from public service. The talks and papers included in this series take the form of academic papers, articles for publication, draft book chapters, book reviews, speeches, and transcripts. Supporting documentation is also included; correspondence, travel receipts, notes, published materials, and "see" and "see also" references are sometimes included along with the products Bissell wrote. The folders in this series are arranged in chronological order. Undated materials are filed in the first nine folders but seem to be roughly chronological in arrangement. The contents of each folder are primarily arranged in reverse chronological order. Exceptions may exist in the cases of drafts, notes, supporting documentation and undated materials.

This series seems to have served as a "ready reference" file of nearly every extant intellectual product created by Bissell. While some works in this series are in their original format, others are merely copies of the originals that are filed elsewhere in the collection. In several instances, a work of Bissell's in this series is housed with related correspondence apparently removed from either what is now the Correspondence Series of this collection or from elsewhere. In other cases, folders house "see" or "see also" references linking the folder to correspondence, other folders in this series, or other folders that are now housed in different series across this collection. Researchers may find that particular folders hold nothing but a "see" reference authored by Bissell's office staff pointing to another physical or file folder location that was current when his office staff first created these files but now no longer exists. In the event that researchers are unable to easily locate an item pointed to in a "see" reference, they are encouraged to examine the finding aids for the other series in this collection as folder titles have not been changed.

In some cases, folders house information that significantly postdates the work Bissell created. For instance, the folder housing Bissell's "The Anatomy of Public Spending" article published in 1942 in *Fortune* includes not only the article itself but also a dictated 1992 file letter from Bissell explaining his interpretation of its historical significance and a list of correspondence speaking to the article's creation and reception.
