The oral history administrative records were retired from use between 1972 and 1990 and transferred to the manuscript collection in 2016. Documents in this collection were created as government records, part of Record Group 64 Records of the National Archives and Records Administration, and are in the public domain.

SCOPE AND CONTENT NOTE

In 1960 the Columbia University Oral Research Office approached President Eisenhower seeking to put in charge of oral history interviews of key members of the Eisenhower Administration. By October 1962 Columbia had not been able to secure funding for the project so the Director of the Eisenhower Library made plans to start an in-house oral history program. Beginning in 1963 the staff began interviewing Abilene, Kansas residents who either knew the Eisenhower family or were part of the Eisenhower Foundation. They began plans to assist Columbia in moving forward with their part of the oral history program. Library staff drafted a list of potential interview subjects from the Eisenhower administration and devised a strategy for fundraising.

Columbia began their first interviews for the project in 1966 after securing a grant from the National Endowment for the Humanities (NEH). Columbia sent copies of transcripts and tapes from their Eisenhower Project interviews to Abilene, the first batch arriving in 1967. Additional grant funding to continue the project came from an NEH and from contracts with the National Archives and Records Administration.

With the Columbia University project winding down in the 1970s, the scope of the Eisenhower Library program was expanded. The library hired two oral historians, Mac Burg and Tom Soapes, and expanded the program budget to include interview trips across the country and as well as to Europe and to British Columbia, Canada. A workflow for support staff was devised that allowed more oversight for the program and the ability to check on the processing progress for individual interviews.

Documents in this collection are arranged into the following series: Administrative Files, Interview Trip Files, Interview Processing Files, Columbia University Oral History Research Office, Supporting Documents, and Index Card Files. Documents are arranged alphabetically within each each series. Acronyms NLE and DDEL that appear in these files, both refer to the Eisenhower Library.

SERIES DESCRIPTIONS

Series I: Administrative Files

Boxes 1-2

This series consists of records relating to the beginning and implementation of the Eisenhower Library oral history program. Documents in the series include planning documents, lists of potential interviewees, status reports, correspondence, memoranda, and background materials used for researching topics and compiling lists of interviewees.

Series II: Interview Trip Files

Box 2-3

This series consists of planning materials for oral history interview trips. Documents in the files include background information on interviewees, plans for hotels and transportation, itineraries, and other related documents

Series III: Interview Processing Files

Boxes 3

This series includes information on how the library staff produced use copies of tapes, transcribed the interviews, obtained Gift of Personal Statement (GPS) forms or deeds of gift, and made the interviews ready for use by researchers. Also included are quarterly and monthly reports on the activities of the oral history staff from 1972 through 1990.

Series IV: Columbia University Oral History Research Office

Box 3-4

In 1967 the Eisenhower Library began receiving oral history transcripts and tapes from the Columbia University Oral History Research Office. In 1969 Archivist of the U.S. James Rhoads signed a formal contract to support the Eisenhower Project at Columbia and formalize the exchange of materials. This contract was renewed in 1971. In 1982 many of the Columbia transcripts were microfilmed by Microfilming Corporation of America. This series consists of correspondence, memoranda, lists, and other related documents.

Series V: Supporting Manuscripts

Box 4

This series contains correspondence and other supporting materials received from individuals who were interviewed by the oral history staff or the Columbia University Oral History Research Office. Documents include correspondence, background documents, interviews not conducted by the Eisenhower Library.

Series VI: Index Card Files

Boxes 5-8

This series consists of a card index created in 1972 which was used to identify persons as potential oral history subjects. The cards are divided into three groups: a geographic index, a name index and an index to subjects, relationships or positions held by the individual. The geographic index is arranged by state or Canadian province. Countries are filed alphabetically with the states. For instance, cards for Argentina would be filed between those for Alabama and Arkansas.

Some cards have annotations regarding sources of more information about the person named on that card, primarily *Who's Who in America*. Some cards list the *White House Staff Book*, a biographical publication of members of Eisenhower's staff that is available in our research room and no the Library web page. The subject and geographic card sometimes refer back to the name cards, calling them address cards. References to 'Carol's address file' relate to a temporary file kept by the administrative staff that no longer exists. The oral history solicitation file is an internal Library file mentioned occasionally but not available for researcher use.
