1. Papers that are security-classified until such classifications shall be removed.
2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
3. Papers containing statements made in confidence unless the reason for confidentiality no longer exists.
4. Papers relating to family or private business affairs.
5. Papers containing statements which might be used to injure, harass, or damage any living person.

DESCRIPTIVE NOTE

This series of the White House Central Files consists of printed material (mostly annual reports) issued by various private companies and organizations, and a number of state, county and municipal agencies. These publications were sent to the White House for the information of the President and his staff. When such publications were accompanied by correspondence they were usually filed with the correspondence in other series of the White House Central Files, or were turned over to the Library of Congress for cataloging. This series contains the material that did not have accompanying correspondence. The publications are arranged in alphabetical order by name of organization. Three books and one U.S. government publication were transferred to the Eisenhower Library book collection.
