SCOPE AND CONTENT NOTE

Dr. Neil H. Jacoby was granted a leave of absence from his position as Dean of the Graduate School of Business Administration of the University of California at Los Angeles to accept an appointment as member of President Eisenhower's reconstituted and reorganized Council of Economic Advisors.

The reorganization plan, which was submitted by President Eisenhower and approved by Congress, limited the Council's access to the President, permitting accessibility only to the Council's Chairman. The plan also granted the Chairman more authority in both policy and administrative matters. Dr. Arthur F. Burns became Eisenhower's first appointment to the Council, serving as Chairman. Dr. Jacoby was the President's second appointment made to the Council.

The papers of Neil H. Jacoby span the years 1952-63. However, about seventy-five per cent of the collection covers the years 1953-55 when Dr. Jacoby was a member of the Council of economic Advisors. Included are memoranda, reports, press releases, and correspondence on such topics as fiscal policy, taxation, anti-recession policies, anti-trust measures, foreign economic policy, private and public housing, commercial banks, capital gains taxes, and many other economic issues and organizations.

Approximately fifteen per cent of the papers consist of letters acknowledging Jacoby's appointment to and resignation from the Council of Economic Advisors, as well as private business and personal matters. The remainder of the collection deals with Dr. Jacoby's role as a consultant to the Council on small business in 1956 and as a correspondent with various members of the Council on several official or personal matters after his resignation.
