#### SCOPE AND CONTENT NOTE

The Marx Leva Papers contain materials pertaining to his legal career, his navy service, his work in government, and his personal life. They reflect his enduring interest in national security matters and to some extent in politics. Much of the collection pertains to the Truman Administration; the Leva oral history at the Truman Library may also be useful to researchers. There was no particular order to the materials as received, and they have been arranged into three slightly overlapping series described below. Materials within each series are arranged in rough chronological order.

Marx Leva was born to a Jewish family in Selma, Alabama. He distinguished himself in academics and graduated from the University of Alabama and Harvard Law School. Following graduation, Leva clerked for Supreme Court Justice Hugo L. Black. The Second World War interrupted his legal career, and he spent a year or more with the War Production Board before enlisting in the Navy in July, 1942. He was initially sent to North Africa. As navigator on LST 386, an early aircraft carrier, Leva participated in the invasion of Sicily, earning a Bronze Star for his actions. In January, 1945, Leva was assigned to the Bureau of Ships in the Navy Department, beginning a steady climb to Assistant Secretary of Defense in 1949. He was a key figure in the controversial unification of the armed services into the National Defense Establishment (later the Department of Defense).

To better provide for his family, Leva resigned from government service in 1951 to pursue a legal career. He became a partner in the law firm of Fowler, Leva, Hawes and Symington. He was associated with the quasi-government Institute for Defense Analyses, and served on the President's Committee to Study the United States Military Assistance Program (Draper Committee) and shortly thereafter, the Committee on the Defense Establishment (Symington Committee. Researchers interested in the Draper Committee are advised that its records are available at the Library. Leva died in Bethesda, Maryland, in 1997.

Series 1: PRINT MATERIALS, 1939-90

This series consists of books, reports, studies, congressional hearings, newspapers, magazines, and clippings, mostly relating to World War II and national security in the post-war era. The items reflect Leva's Navy service in World War II, his post-war career in the Defense Department, and his work on the Draper Committee. There is a notable selection of foreign and domestic World War II-era newspapers, including many from North Africa, in English, French, Spanish, and Italian. Many of the other items consist of Congressional hearing and reports. Sixteen larger books were transferred to the Library's book collection.

Series 2: MILITARY AND LEGAL CAREER, 1938-87

This series consists of correspondence, clippings, press releases, statements, forms, memorandums, and other documents from Leva's military service and law career; some personal correspondence with friends and family is also included.

Most of the records fall into four categories. The unification of the armed services into the National Defense Establishment, and later the Department of Defense in the late 1940s and early 1950s comprises the first category. As an assistant to James Forrestal and later Louis Johnson, Leva played a key role in this process, and maintained a lifelong interest in the organization of the Defense Department and national security. The second category consists of Leva's interest in, and defense of, the life and career of Secretary of Defense James Forrestal. Leva contemplated writing a biography, and drafted several articles. Some of his correspondence concerns his interest in Forrestal. The third category concerns Leva's participation in the Draper Committee, active in 1958-59, which studied the foreign military assistance program. The fourth category concerns the Committee on the Defense Establishment (the Symington Committee), which looked at the organization of the military establishment.

Notable correspondents include Harry Truman, Dwight D. Eisenhower, Herbert Hoover, Hugo Black, William O. Douglas, Chaim Herzog, Stuart Symington, Sam Nunn, Walter Reuther, Arthur Krock, Chester Nimitz, and Lewis L. Strauss. The correspondence is varied in nature, and the overall quantity in not large.

A World War II flag from Leva's ship, LST 386, and an Algerian matchbox have been transferred to the Museum. Fifty-eight total photographs—snapshots and photo portraits—and two reels of motion picture film were transferred to the Audiovisual Department.

SERIES 3: SPEECHES, STATEMENTS, AND WRITINGS, 1947-91 ARC: 6207455

This series consists of speeches written by Leva, various statements, and writings of an historical nature. Most of the speeches involve the unification of the armed services, while most of the writings pertain to the legacy of the late Secretary of Defense, James Forrestal.
