#### SCOPE AND CONTENT NOTE

The papers of Charles H. Paul span the years 1939 to 1960. Judge Paul, a lawyer and superior court judge in the state of Washington, was heavily involved in state Republican Party politics and his papers primarily contain information regarding his political activities. For two years, he served as the state manager for Robert Taft, who competed against Eisenhower in 1952 for the Republican presidential nomination. The papers consist of correspondence, speeches, political and biographical materials. Folder titles and general arrangement were assigned by the processing archivist.

The correspondence folders, arranged in alphabetical order, contain the most substantial portion of the papers. Located there are outgoing carbons form Judge Paul and incoming letters from individuals active in state and local Republican political activities, a great many of whom were Taft supporters. Included in the correspondence is a letter from DDE and a folder devoted solely to Taft that contains correspondence between Paul and Taft as well as other correspondence relating to Taft.

The speeches are arranged chronologically and consist of transcripts and drafts of speeches given by Paul to various organization in Washington in support of the Republican party.

The political materials contain a variety of items including newspaper clippings, an "Eisenhower for President" bulletin, and memoranda. The biographical materials are comprised of two biographies of Judge Paul.
