The records of Thomas P. Pike, Special Assistant to the President, were received at the Library with other White House records shortly after the end of the Eisenhower Administration.

The Pike records were reviewed according to the terms of Dwight D. Eisenhower's letter of gift to the Administrator of General Services dated April 13, 1960. According to those terms, the following materials were to be withheld from research:

- 1. Papers that are security-classified pursuant to law or Executive Order, until such classification shall be removed.
- 2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
- 3. Papers containing statements may by or to the President in confidence.
- 4. Papers relating to the President's family or private business affairs, and papers relating to the families or private business affairs of persons who have corresponded with the President.
- 5. Papers containing statements about individuals which might be used to injure or harass them or members of their families.

SCOPE AND CONTENT NOTE

Thomas P. Pike served the Eisenhower Administration as Deputy, then Assistant, Secretary of Defense for Supply and Logistics, 1953-56; as Special Assistant to the President in 1956 and, briefly, in 1958; and as a consultant to the Secretary of Defense in 1957. The Pike records consist of correspondence, memoranda, statistical data, reports and cabinet papers dated mainly 1956 through 1958. The records cover such topics as Kansas unemployment, the federal budget, agriculture, the Renegotiation Board, the 1956 election, the St. Lawrence Seaway, small business matters and policy, and the Veterans Administration. A few items are dated during Pike's tenure as Assistant Secretary of Defense.
