## SCOPE AND CONTENT NOTE

The records of the Commission on Intergovernmental Relations span the years 1953-1955 and consist of the working papers of the Commission itself and its various special study subcommittees.

The Commission records consist of telegrams, correspondence, verbatim transcripts of meetings, minutes of meetings, drafts, and reports on the over-all topic of intergovernmental relations, and the housekeeping duties of the Commission (personnel, records management, supplies, etc.). An important segment of these records are the "state impact" studies of federal grants-in-aid. These studies consist of answers to the Commission's questionnaire by the various state commissions and of reports submitted by professional consultants.

The records of the special study committees consist of telegrams, correspondence, verbatim transcripts of meetings, minutes of meetings, drafts, reports, and questionnaires answered by the particular state agencies and organizations concerned with a specific topic. These topics include: airport construction, agriculture, education, taxation, grants-in-aid, health, highways, housing, Indian Affairs, law enforcement, local government, natural disasters, conservation and natural resources, unemployment compensation, vocational rehabilitation, and welfare.

Within each folder are cross reference sheets to other pertinent files in the collection. In addition, there is an alphabetical name index to the files in the last 10 boxes and two boxes of carbon memoranda written by the Chairman and the Director of Research.

The Commission on Intergovernmental Relations was established July 10, 1953 to study and investigate the following problems: the proper role of the Federal Government in relation to the States and their political subdivisions; an adjustment of intergovernmental fiscal relations; justification for existing Federal aid programs, possible extension of Federal aid, possible limitation of Federal control connected with Federal aid.

Dean Clarence Mannion was appointed first chairman of the Commission and was succeeded in 1954 by Meyer Kestnbaum. Other members of the Commission included: Alfred E. Driscoll, William Anderson, Lawrence A. Appley, John S. Battle, John E. Burton, Marion B. Folsom, Charles Henderson, Oveta Culp Hobby, Sam H. Jones, Clark Kerr, Mrs. Alice K. Leopold, Val Peterson, Alan Shivers, Dan Thornton, Alan Bible, Hubert H. Humphrey, Wayne Morse, John M. Butler, Andrew F. Schoeppel, John D. Dingell, Brooks Hays, James I. Dolliver, Angier L. Goodwin, and Harold C. Ostertag.

The Commission submitted its final report including recommendations for legislative action to the President on June 30, 1955.
