The records of the President's Advisory Committee on a National Highway System (the Clay Committee) were deposited in the Eisenhower Library in May, 1971, by the National Archives.

- 4. All other papers which contain information or statements that might be used to injure, harass or damage any living person.

SCOPE AND CONTENT NOTE

The records of the President's Advisory Committee on a National Highway System span the months from July 1954 to March 1955, but the most significant part of the collection span the months September -- November 1954.

One third of the collection consists of correspondence sent and received by the Committee, memoranda, reports and plans submitted to the Committee, and public opinion on the national highway system. Portions of this file consist of printed material submitted to the Committee concerning construction and financing of various highway systems.

About 40% of the collection consists of testimony and reports made by 22 organizations at the public hearings on October 7 and 8, press releases concerning the hearings and various activities of the Committee, and rough drafts, charts, and maps used in writing the final report to the President. Much of the material presented at the public hearings concerning financing and construction of a national highway system was incorporated into the final report submitted to the President.

The remaining portion of the collection consists of miscellaneous notes and telephone numbers, secretary's shorthand notebooks, 3"x 5" cards on the hearings, and a 3"x 5" card file of correspondents' addresses.

10 items were removed from the records and turned over to the book collection and 11 photographs were turned over to the photo collection.

NOTE ON THE PRESIDENT'S ADVISORY COMMITTEE ON A NATIONAL HIGHWAY SYSTEM

At the Governors' Conference of July 12, 1954, Vice President Nixon, on behalf of President Eisenhower, urged that the nation's highway system be expanded and strengthened because the existing system was obsolete and inadequate.

In response to the invitation from the President to recommend cooperative action which might be taken to provide adequate highways, the Governors created a special seven man Highway Committee with Governor Walter J. Koehler, Jr. of Wisconsin as Chairman. An inter-agency Committee within the Federal government was also established and included representatives from the Departments of Defense, Commerce, Agriculture and Treasury, the Bureau of Budget, and the Council of Economic Advisers.

On September 7, 1954, the appointment of the President's Advisory Committee on a National Highway Program was announced. This Committee was composed of Lucius D. Clay, Chairman of the Board, Continental Can Company, Chairman; Stephen D. Bechtel, of San Francisco, California, President, Bechtel Corporation; David Beck, of Seattle, Washington, President, International Brotherhood of Teamsters; S. Sloan Colt, of New York, President, Bankers' Trust Company; and William A. Roberts, of Milwaukee, Wisconsin, President, Allis Chalmers Manufacturing Company. Mr. F.C. Turner was appointed Executive Secretary of the Committee.

The Committee was requested by the President to study the problem and report back to him, working in cooperation with the Special Highway Committee of the Governors' Conference and the Interagency Committee. Public hearings were held by the Committee in Washington, D.C. on October 7 and 8, 1954 at which 22 organizations associated with the highway problem made proposed construction program.

The conclusions and recommendations of the Committee were reported to the President in January 1955 and the Committee was then terminated.
