GENERAL ORDERS No. 1

20 January 1953

## 1. General.

At 1200 hours, 20 January 1953, President Elect Dwight D. Eisenhower will take the Oath of Office of President of the United States of America, at the Capitol. At 1330 hours he will depart from the Capitol via the Law Library entrance, and take his position in the Inaugural Parade formation. When the President's car reaches its prescribed position, the Parade will move out on order of the Deputy Grand Marshal. The Saluting Battery, 3d Infantry, located at the foot of the steps at the west entrance to the Capitol, will fire a 21-gun salute as the Parade moves out. Upon arriving at the junction of 17th Street and Pennsylvania, NW, the Metropolitan Police, The United States Army Band, and the 1st Battalion, 3d Infantry will continue to move northwest on Pennsylvania Avenue. The Presidential Color Detail will turn into the White House Grounds by the North-West gate and proceed to the Reviewing Stand. The Presidential Party, the Chief of United States Secret Service, the Inaugural Committee, the Grand Marshals, the Chief Justice, and Ex-President Hoover will turn south on 17th Street, proceed to State Place, thence east to West Executive Avenue, and enter the White House Grounds at the North-West gate where the members will dismount and enter the Reviewing Stand. The Chief of Police, the Members Designate of the Cabinet, the Division Marshals, the Governors, and the District Commissioners, will turn south on 17th Street, proceed to State Place, thence east to West Executive Avenue where vehicles will park, personnel dismount and move to the Reviewing Stand. The Press and Radio Media will turn north on Jackson Place and park between "H" Street and Pennsylvania against east curb. The Massed State Colors will continue the march on Pennsylvania Avenue. The 1st Division of the Parade will halt at the junction of Pennsylvania and New York Avenues with the Division Marshal's car on Pennsylvania Avenue, and will move out on signal of the Deputy Grand Marshal (Commanding General, Military District of Washington), to pass in review for the President.

## 2. Participating Armed Forces and Civilian Elements of the Parade.

See Annex 1 (Troops and Organizations in Order of March) and Annex 3 (Schematic Diagram—Distance of and between Elements).

## 3. The Parade.

*a. Starting Time.* 1330 hours (1:30 P. M.), 20 January 1953.

*b. Initial Point (IP).* The Initial Point (IP) is the intersection of New Jersey and Independence Avenues, see Diagram 1 (Assembly Areas) to Annex 2 (Movement Table), except for the Presidential Division which will form on the Capitol grounds while the President is having lunch at the Capitol.

*c. Assembly Areas for Divisions.* See Diagram 1, Annex 2.

- (1) The responsibility for planning the disposition of the Division elements in the Assembly Area and for the organization, orientation, and supervision of the Division in the Assembly Area is delegated to the following:

- (a) *The Presidential Division.* The Commanding Officer, 3d Infantry Regiment. He is further responsible for the orientation and disposition

of the Saluting Battery and for the supervision of its operation in the ceremony; for the organization and orientation of the Presidential and State Color Details; and for coordinating with the United States Secret Service on the integration of the official Parade and authorized press and photographic representatives in the Presidential Division at the outset of the Parade.

- (b) *1st Division.* Deputy Division Marshal, Colonel Harold R. Jackson, United States Army.
  - (c) *2d Division.* Deputy Division Marshal, Captain C. A. Buchanan, United States Navy, Commandant of Midshipmen.
  - (d) *3d Division.* Deputy Division Marshal, Captain Leon H. Morine, United States Coast Guard.
  - (e) *4th Division.* Deputy Division Marshal, Captain John T. Everett, United States Maritime Service.
  - (f) *5th Division.* Deputy Division Marshal, Colonel James T. Duke, United States Army.
  - (g) *6th Division.* Deputy Division Marshal, Colonel George R. E. Shell, United States Marine Corps.
  - (h) *7th Division.* Deputy Division Marshal, Colonel Charles W. Sawyer, United States Air Force.
  - (i) *8th Division.* Deputy Division Marshal, Colonel Robert F. Cocklin, United States National Guard.
  - (j) *9th Division.* Deputy Division Marshal, Colonel Waldron E. Leonard, Director Veterans' Service Center, District of Columbia.
  - (k) *10th Division.* Deputy Division Marshal, Colonel Hugh Everett, United States Army.
- (2) Troops and organizations will assemble closed up on the right hand side of the street and facing the direction of the march as indicated in Annex 3. The sequence of units will not be changed. Proper distance will be taken as the Parade moves out.
- (3) A Command Post and Information Center will be established at the Initial Point (IP) by the Deputy Grand Marshal to control the movement of all Divisions passing the IP.

*d. The Parade Route.* See Diagram 2 (Parade Route) to Annex 2 (Movement Table).

*e. The Cadence and Step.* The cadence and step for marching units will be 120, 30-inch steps, per minute.

*f. The Reviewing Stand.* On the south side of Pennsylvania Avenue in front of the White House.

*g. Distances, Formations, and Intervals.* Distances, formations, and intervals for the Parade follow (elements which are unable to maintain prescribed distances because of mechanical difficulty, or are unduly extending their distances, or are interfering with the rate of march of the Parade, will be withdrawn and reintegrated behind the last scheduled element of the 10th Division):

(1) *Distances.*

- (a) Distance between elements of military units or State groups within a Division—20 yards.
- (b) Distance between separate Military units, State groups, and between battalions within a division with colors in the interval—30 yards.
- (c) Distance between Divisions—50 yards.
- (d) Distance between vehicles:
  - 1. Cars and jeeps—5 yards.
  - 2. Heavy equipment and tanks—10 yards.
- (e) Distance between horse mounted units—25 yards.

(2) *Marching Formation Criteria.*(a) *Military, dismounted.*

1. Major Units—16 man front at close interval.
2. Small and Composite Units—12 man front at close interval.

(b) *Military, motorized.*

1. Heavy equipment—2 abreast, 20-foot interval.
2. Light equipment—3 abreast, 10-foot interval.  
(Unless in column with heavy equipment).

(c) *Civilian, dismounted (per mass).*

1. 100 men or less—8 man front, at normal or more than normal interval.
2. 100 to 200 men—12 man front at normal interval.
3. Over 200 men—16 man front, at close interval, 3 inches between men.

(d) *Civilian, mounted (horse)*—Minimum of 8 abreast, depending on the size of unit, 8 feet between ranks.(e) *Civilian, motorized*—3 abreast.(f) *Massed Color Details*—12 man front, at normal interval, 5 feet between ranks.

*h. National Colors.* Only one set of *National colors* will be allotted to each of the Parade Divisions, and these will be carried by the Armed Forces unit leading each Division. In the case of the 9th and 10th Divisions, where there is no Armed Forces unit leading the Division, National Colors will be massed at the head of the Division. Past experience indicates that so many National flags have been carried in parades that the requirements of rendering honors have been repetitious to such a degree as to detract from the dignity of this simple tribute. The plan indicated above will limit to eleven the number of occasions during the parade where reviewing officials and spectators will be expected to stand and render appropriate honors, i. e., once for the massed colors in the President's party and once for the National Colors carried by each of the ten parade Divisions.

*i. Honors at the President's Reviewing Stand.*(1) *By Armed Forces Elements.* Eyes left.(2) *By Armed Forces Band only.* Four ruffles and four flourishes, followed by music as below:

- (a) Army Bands—"The Army's Always There."
- (b) Marine Bands—"Marines' Hymn."
- (c) Navy Bands—"Anchors Aweigh."
- (d) United States Coast Guard Band—"Semper Paratis."
- (e) United States Air Force Band—"Air Force Song."

(3) *Bands.*

- (a) Bands, Drum and Bugle Corps, etc., *will not* play before passing the initial point. (See Diagram 1, Annex 2).
- (b) Bands *will* play while passing the East Wing of the Capitol Building and while passing the President's Reviewing Stand.
- (c) All bands, except the United States Army Band, will cease playing when they reach "G" and 15th Streets, N. W., and will not again play until they reach The Riggs Bank. (Positions will be marked by a black and white sign).
- (d) Bands may play at any time during the parade except as noted above. Bands marching close together will coordinate their playing in order to avoid interference.
- (e) All bands will maintain a distance from the preceding unit not to exceed 20 yards.



- (f) All bands will maintain a frontage such that over-all length will not exceed 30 yards.
- (g) All Armed Forces bands will render honors; civilian bands will not be required to render honors but may if so desired.
- (h) No unusual marching movements will be permitted; bands or mounted or marching units will *not* reverse direction nor change pace.
- (i) All Presidential honors will commence when the front rank of each band reaches the black and white sign located on the South (left) side of Pennsylvania Avenue, East of the Reviewing Stand.

#### 4. Dispersal Areas.

- a. Diagram 3 (Dispersal Areas) to Annex 2 (Movement Table).
- b. A Command Post will be established by the Deputy Grand Marshal at Washington Circle to supervise the dispersal of Divisions. Commanding Officer of Dispersal Area—Lt. Col. C. B. Reed, USA.
- c. The Commanding Officer, 3d Infantry Regiment, will furnish three guide details of one officer and five enlisted men each. These details will report to Command Post at Washington Circle at 1200 hours, 20 January. These details, augmented by five similar details from the Navy, Marines, Air Force, Coast Guard, and National Guard, will meet the Divisions at 19th Street and Pennsylvania Avenue and escort or direct all units to their entrucking point or dispersal area as directed by the Commanding Officer, Dispersal Area.

#### 5. Aerial Review.

- a. Under the direction of the United States Air Force, an air cover will be provided by the United States Air Force and the Air Arm of the United States Army, the United States Marine Corps, and the United States Navy as follows:
  - (1) United States Army—1400-1430.
  - (2) United States Marine Corps and United States Navy—1430-1500.
  - (3) United States Air Force—1500-1545.
- b. Flights will be made between 1500 and 2500 feet.
- c. The following aircraft will participate:

- d. Details outlining air operations are set forth in Operations Plan Serial No. 1-53 (separate cover).

#### 6. Security Cordons.

- a. *Capitol.* A security cordon composed of 100 men each from the Army (3d Infantry), Navy Air Force, and Marines, under command of Major M. A. Hull, USMC.
- b. *Parade Route.* A combined cordon under command of Lt. Col. Carl A. Weaver, 3d Infantry, to be disposed as requested by Chief of Metropolitan Police. Composition—450 officers and enlisted men from Arlington Hall Station, 450 officers and enlisted men from the Officers' Candidate School, Fort Belvoir, 300

officers and enlisted men from the 3d Infantry, 200 officers and enlisted men from the United States Air Force, 225 officers and enlisted men from the Marine Corps.

*c. Armed Services Police Detachment.* The Armed Services Police Detachment in coordination with the Metropolitan Police is responsible for coordinating the escort of all elements to the assembly area, from the assembly area to the dispersal area, and away from the dispersal area. See Annex 2 (Movement Instructions). The Armed Services Police Detachment will provide a cordon of 2 officers and 20 enlisted men around the Presidential Box at the Reviewing Stand at the White House.

## 7. Uniform.

Uniform for all Armed Forces elements will be as prescribed by appropriate commanders.

## 8. Medical Plan.

*a. Emergency Treatment.* Emergency treatment at First Aid Station and evacuation will be handled by the American Red Cross, with the assistance of the Armed Forces.

## 11. Signal Communications.

*a.* Signal Officer, Military District of Washington, will establish three radio nets. Radio net No. 1 is established for control of the Parade by the Deputy Grand Marshal, and consists of 16 stations, including the net control station. See Diagram 1, Annex 3. Radio net No. 2 will be established for the use of the Inaugural Committee. This net will consist of seven stations, including the net control station. See Diagram 2, Annex 3. Net No. 3 is a stand-by net, and will be utilized by the Inaugural Committee as necessary. See Diagram 3, Annex 3.

*b.* In the event that any Armed Forces elements participating in the Parade desire to use radios for interior control, frequencies must be cleared with the Signal Officer, Military District of Washington prior to 18 January 1953.
